Admission Policy

**ADMISSION IS OPEN TO ALL APPLICANTS WHO
MEET THE ENTRANCE REQUIREMENTS REGARDLESS
OF AGE, SEX, RELIGION, AND ETHNICITY.**

**TO QUALIFY FOR ADMISSION, AN APPLICANT MUST, AS DETERMINED BY
THE ENTRANCE EXAMINATION RESULTS AND PERSONAL INTERVIEW:**

1. SPEAK, READ, AND COMPREHEND THE ENGLISH LANGUAGE;
2. COMMUNICATE EFFECTIVELY;
3. UTILIZE INTELLECTUAL ABILITIES, EXERCISE GOOD JUDGMENT AND COMPLETE TASKS WITHIN REQUIRED TIME LIMITS;
4. SHOW INTEGRITY, CONCERN AND RESPECT FOR OTHERS, INTERPERSONAL SKILLS, INTEREST AND MOTIVATION;
5. BE 17 YEARS OF AGE OR OLDER (A PARENT, LEGAL GUARDIAN, OR SPOUSE OF LEGAL AGE MUST CO-SIGN THE ENROLLMENT AGREEMENT FOR APPLICANTS UNDER 18);
6. HAVE A MINIMUM OF EITHER A U.S. HIGH SCHOOL DIPLOMA FROM AN ACCREDITED SCHOOL, OR ITS EVALUATED FOREIGN EQUIVALENT; OR HAVE PASSED ANY OF THE FOLLOWING EQUIVALENTS: GENERAL EDUCATIONAL DEVELOPMENT CERTIFICATE (GED), HIGH SCHOOL EQUIVALENCY TEST (HISET) AND THE TEST ASSESSING SECONDARY COMPLETION (TASC);
7. PASS THE ENTRANCE EXAMINATION AND PERSONAL INTERVIEW REQUIREMENT.

- U.S. POST-SECONDARY DIPLOMA OR TRANSCRIPT (FOR ALL PROGRAMS/SCHOOLS ATTENDED AFTER HIGH SCHOOL), IF APPLICABLE
- EVALUATED FOREIGN HIGH SCHOOL OR POST-SECONDARY CREDENTIALS (ORIGINAL OR COPY), IF APPLICABLE
- CREDIT GRANTING FORM, IF APPLICABLE
- CNA CERTIFICATE (COPY) AND/OR HHA CERTIFICATE (COPY), IF APPLYING FOR CREDIT

Administration, Staff, & Faculty

The Administration, staff, and faculty have years of education, training, and experience in the areas of nursing, medical and health care, guidance and counseling, management, as well as school administration and operations.

Program Delivery

The Vocational Nursing Program is delivered by Blended Instruction. Theory instruction and materials will be delivered through a combination of in-person classroom sessions and distance learning classes through GoToMeeting.com and Google Classroom. Skills laboratory and clinical sessions will be delivered in-person, on campus and at affiliated facilities to practice as an LVN in California..

Awards for Completion

Upon successful completion of the Program, a Diploma will be granted. The graduate will be eligible to take the National Council Licensure Examination for Practical Nurses (NCLEX-PN®). A passing score in the NCLEX-PN® grants eligibility to apply for vocational nurse licensing with the California Board of Vocational Nursing and Psychiatric Technician (BVNPT). A license is required to practice as an LVN in California..

Credit Granting

Students who have completed academic courses in other accredited institutions or have relevant experiential learning may be given credit upon meeting specific criteria.
